

ORDINANCE NO. 664

AN ORDINANCE OF THE CITY OF SALEM, SD, AMENDING THE COMPILED ORDINANCES OF SALEM, BY AMENDING CHAPTER 2.02 – WARDS AND VOTING PRECINCTS

BE IT ORDAINED BY THE CITY OF SALEM, SD:

Section 1. That Chapter 2.0201 – Wards and voting precincts of the Compiled Ordinances of Salem is hereby amended to read as follows:

2.0201 - Wards and voting precincts.

The city shall be divided into three wards, which shall be combined and consolidated into one election precinct, and shall be designated respectively as Wards One, Two and Three. The wards shall be described by setting for the certain street or avenue designations or other landmarks that divide and border the wards. Any reference to street or avenue below shall mean an imaginary line running down the approximate middle of each street or avenue. The wards of the City of Salem are as set forth below and the map thereof. Any discrepancies shall be resolved by reference to the map rather than the physical descriptions set forth herein. A map illustrating the boundaries and location of each ward is kept on file with the finance officer at city hall.

Ward One will encompass that portion of the city lying within the following described boundaries:

All that portion of the city lying east of the center line of Nebraska Street starting at the center line of Drake Avenue and extending South to the city limits; and that portion of the city lying east of the center line of Douglas starting at the center line of Hollister Ave and extending South to SD Hwy 38; and that portion lying east of the center line of Douglas street starting at the center line of Center Ave and running east to the center line of Gilbert Ave and South to Hollister Ave; and that portion lying west of the center line of Nebraska Street starting at the center line of SD Hwy 38 and extending South to the city limits.

Ward Two will encompass that portion of the city lying within the following described boundaries:

All that portion of the city lying south of the center line of Richard Avenue starting at the center line of Dakota Street extending south to the center line of Washington Avenue and east to the city limits; and that portion of the city lying south of the center line of Washington Avenue and east of the center line of Minnesota extending south to the center line of Drake and east to the city limits; and that portion of the city lying south of the center line of Essex Ave and East of the center line of Dakota Street extending south to the center line of Norton Avenue and east to the center line of Minnesota.

Ward Three will encompass that portion of the city lying within the following described boundaries:

All that portion of the city lying south of the center line of Richard from the west city limits to the center line of Nebraska Street to the center line of SD Hwy 38 (excluding the area described as that portion lying east of the center line of Douglas street starting at the center line of Center Ave and running east to the center line of Gilbert Ave and South to Hollister Ave and that portion of the city lying east of the center line of Douglas starting at the center line of Hollister Ave and extending South to SD Hwy 38); including that portion of the city lying south of the center line Richard Avenue from the center line of Nebraska Street east to Dakota Street and south to the center line of Norton Ave; including that portion of the city lying south of the center line of Norton Ave east to the center line of Minnesota; and the block lying between center lines of Main, Essex, Minnesota and Washington; and all of the south 270' of the west 415' of the SW ¼ of the SW ¼ of 12-103-55.

All ordinances or parts of ordinances in conflict herewith are hereby repealed insofar as the conflicting portions thereof are concerned.
