MINUTES OF THE REGULAR MEETING OF THE SALEM CITY COUNCIL HELD IN THE MCCOOK CENTRAL SCHOOL DDN ROOM IN SALEM SOUTH DAKOTA ON TUESDAY, OCTOBER 10, 2023, AT 6:00 P.M.

Mayor Glenda Blindert called the meeting to order with Council Members Doug Mokros, Ron Mayrose, Mitchell Rayman, Marc Harris, Janet Karel and Dnyee Schierholz present. Foreman Dustin Weber; Jacob Morris and Trent Bruce of DGR Engineering; Jeff Twedt of Twedt Construction; Allen Schmeichel and LuAnn McKillip were also present.

Motions made were unanimous of Council members present unless roll call identifies otherwise.

Motion Mokros, second Karel, carried, to approve the agenda.

No one was present for public comment (SDCL 1-12.1).

Motion Mokros, second Schierholz, carried, to approve following consent agenda items:

Foreman Weber presented the following items:

- A. Street Closure request: St Mary's Fall Festival 10/29/2023. Idaho (Vermont & Essex). LuAnn McKillop representing the St. Mary's Fall Festival Committee, explained the kids' games are to be outside, but if inclement weather exists, they will be moved to the St. Mary's School building closing the road would provide safe travel between the school and hall. Permission to close Idaho between Vermont Ave and Essex Ave between 11AM and 3PM if the games are moved to the school.
- B. Snow Hauling: looking for other options to haul snow. SEDC has approved hauling this season, but if they sell more lots this property won't be available.
- C. WTP discussion on filtration systems. Weber updated the council on the NANO filters, they cleaned up and are now maintaining pressure. Still working on determining the cause of oxidation.

Motion Mokros, second Rayman, carried, to approve the closure of Idaho from Essex to Vermont on October 29th, 2023, from 11 a.m. to 3 p.m. if necessary to move games to St. Mary's School.

Engineer Report: Jacob Morris and Trent Bruce of DGR provided the Council with a project update.

- A. <u>Industrial Area Project</u>: Still waiting on paperwork from the contractor for a change order for the additional 400' of work, and fire hydrants.
- B. <u>Phase II Trail System</u>: Discussion held on two scenarios provided by DGR to place the trail next to the curb. (8' trail and 10' trail discussed); clear zone safety; streetlights, hydrants, etc. are more of a challenge placing the trail next to the curb. A ten-foot-wide path would cost an additional \$25T.
 - Phase II will run from McCook Central School (west side of Minnesota) to the north side of Washington East to the softball fields; and north on the westside of Peck to the new community center. Project will be constructed in 2025. Once these changes are made to the plans, the abutting property owners will be invited to a meeting.

Motion Karel, second Harris, to design an 8' wide trail next to the curb. On roll call four (4) "Aye" (Rayman, Harris, Karel, Schierholz); two (2) "Nay (Mokros, Mayrose). Motion carried.

C. <u>Peck Street Water Main/Hydrant relocation</u>: Received quote from Twedt Construction for \$99,983 with completion dates of 11/10/2023 (asphalt & concrete); Final 12/15/2023. Jeff Twedt was present to answer any questions on the project timeline.

Motion Mokros, second Mayrose, carried, to approve the Construction Agreement with Twedt Construction for the relocation of the water main on Peck Street (Richard to Jefferson) at a cost of \$99,983.00 with a 11/10/2023 completion date for asphalt and concrete and final completion date of 12/15/2023 (weather permitting).

D. **2022 Street Project**:

- Twedt requesting the paving of Pierce & Center postponed to spring of 2024 to allow the areas disturbed for water/sewer service line connections to go through a freeze thaw cycle. The council is okay with this as long as done by the first part of June.
- Twedt Construction Pay Request #7 -\$69,919.99.

Motion Rayman, second Harris, carried, to approve the postponement of paving Pierce and Center until 2024 (May/June) and Twedt Construction's pay request #7 in the amount of \$69,919.99 for the 2022 Street Project.

E. A&C Business Water Shut-Off: Allen Schmeichel was present to request the water shutoff valve be moved to the street ROW and discuss the drain behind the curb. Schmeichel also brought to the Council's attention that a recent survey has determined approximately 2' of the cement on the south side of his building is on City Property (was present when purchased). Schmeichel stated he would like to have the Council consider selling him a portion of the abutting property as an addition for a garage would work better on the south side of the property, due to the slope and storm sewer easement on the north side.

Council will have DGR investigate the drain behind the curb to determine the best fix if cement or sidewalk is added to this location. The council will consider Schmeichel's request regarding the abutting property.

Motion Rayman, second Mayrose, carried, to move the curb stop into the ROW.

<u>SEDC Update</u>: Mayor Blindert provided an update on the SEDC Housing Grant application. Anticipating the SD Housing Board will decide on the SEDC Housing grant application at their November meeting.

At 7:00 p.m. a public hearing was held to consider the assessments for the abatement of nuisances and non-payment of fees in the City of Salem for FY2023. No one was present for the hearing and the mayor read a letter received for 321 W Vermont Ave.

Motion Rayman, second Mokros, carried, to approve the following assessment for the abatement of nuisances in the City of Salem for FY2023 to be filed with the McCook County Auditor if not paid on or before October 30, 2023.

<u>City Hall/Community Center Project Update</u>. Second Cost estimate was provided on Friday, September 22nd. The council reviewed items removed or changed from the project scope to keep the project within budget. HVAC is still being worked on along with the fire suppression system. Code Officer Fillingsness is working with an HVAC designer and feels the building should have a split system and will provide more details to the city this week to present to ISG's design team.

Committee Reports.

Residential Garbage bids were opened at 2:00 p.m. on Thursday, October 5th as published. One bid was received from RBS Sanitation for the 3-year contract (FY2024-FY2026) in the amount of \$330,939.00 – annual sum of \$110,313.00. This is a 31.65% increase.

Motion Mokros, second Rayman, carried, to accept the bid from RBS Sanitation for Residential garbage pickup for FY2024-FY2026 for a total contract cost of \$330,939.00.

Motion Rayman, second Karel, carried, to approve Resolution 2023-19 a resolution setting 2024 Garbage Rates - \$3.32 increase.

Storm Sewer Surcharge will need to be reduced once US Bank provides an amortization schedule. The 2021 Storm Sewer Project was awarded ARPA dollars so not all the \$847,000 CWSRF award was needed.

Motion Mayrose, second Rayman, carried, to approve the 2024 Delta Dental rates of \$46.70 – Single and \$118.40 Family (\$2 and \$4.80 increase respectively).

Motion Karel, second Mokros, carried, to approve the 2024 Wellmark Blue Cross – Blue Select Primary 2500 - monthly premiums single \$777.66; family \$1,745.49. Decrease of 21.67%.

Motion Rayman, second Harris, carried, to approve the addition of Brian Ewoldt to the Salem Volunteer Fire Department roster on 9/18/2023.

Council member Rayman updated the Council on the fund raising for the Baseball field improvements. Rayman stated that the fund raising has surpassed the anticipated need for the fence project and they have enough dollars raised to place a cover over the grandstand. Cover would be attached to posts and would be a solid structure – no cost to the city.

Motion Rayman, second Mokros, carried, to allow the grandstand cover.

Finance Officer Heumiller provided an update on the May 12, 2022 & July 5, 2022, storm damage insurance claims and FEMA disaster declaration. A few projects still need to be completed for the insurance claims to be closed and FEMA disaster funds have been received and disaster closed out.

The council was provided correspondence from Xcel Energy regarding the transmission line replacement project.

Next meeting is scheduled for Tuesday, November 7, 2023.

Motion Raman, second Mayrose, carried, to adjourn at 7:42 PM.
