

MINUTES OF THE SPECIAL MEETING OF THE SALEM CITY COUNCIL HELD IN THE MCCOOK CENTRAL SCHOOL CONFERENCE ROOM IN SALEM SOUTH DAKOTA ON TUESDAY, SEPTEMBER 24, 2024, AT 6:00 P.M.

Mayor Glenda Blindert called the meeting to order with Council Members Doug Mokros, Ron Mayrose, Mitchell Rayman, Marc Harris, Janet Karel and Dnyee Schierholz present. Tyler Tordsen of SMGA and Randy Sabers were also present.

Motions made were unanimous of Council members present unless roll call identifies otherwise.
